SLEEVE PACK: Rows of cones are overwrapped with HDPE film and placed inside a master corrugated case which is tape sealed. Cases labels are placed on a major and minor case panel and oriented on the pallet so that at least one label faces outward.						
DISPENSER PACK: 4 rows of product separated by chipboard dividers are bagged in a LDPE bag and tape sealed. The bagged product is inserted into a manually sealed paperboard carton, which is then placed in a master corrugated case and tape sealed.						
BULK PACK: Product is packed in layers separated by chipboard liners and paper cushions which is then bagged with a LDPE bag and tape sealed. The bagged product is placed inside a master corrugated case and tape sealed.
