Our eco-friendly products are so numerous that this edition only includes Carrousel's most popular lines of products. Those will help businesses and organizations replace items targeted by regulations prohibiting the sale and distribution of single-use plastic items (SUPs).

The City of Montreal's regulations came into effect on March 28th, 2023. In the rest of Quebec, some municipal regulations are already in place or will be implemented soon. By the end of December 2023, the sale of certain SUPs will be prohibited throughout Canada. It has been prohibited to import or manufacture them as of December 2022.

Pre-consumer recycled contents are materials that are redirected from the disposal stream during the manufacturing process and introduced for use in a different industrial manufacturing process.

Post-consumer recycled contents are materials that are generated by homes or commercial, industrial or institutional installations (in their role as end-users of a

product), which can no longer be used for their original



A biodegradable product is likely to be completely decomposed by living organisms.3 The OECD 301D test protocol (Organization for Economic Cooperation and Development) certifies that a product is biodegradable.

If a product has the test procedure logo, it means that at least 60% of the residue left by the product will naturally decompose in less than 28 days.

ECOLOGO certified products are certified for reduced environmental impact. ECOLOGO certifications are voluntary, multi-attribute, lifecycle based environmental certifications that indicate a product has undergone rigorous scientific testing, exhaustive auditing, or both, to prove its compliance with stringent, third-party, environmental performance standards.²



Composting is a biological treatment process that allows for the biodegradation (biooxidation) of organic waste, under the action of aerobic microorganisms (living in the presence of oxygen). The organic waste is first mixed with structuring agents (e.g. wood chips) to increase aeration, then placed in windrows, piles or in a reactor.

Compost is obtained after reaching a thermophilic phase (temperature between 45°C and 70°C) and a subsequent maturation phase.5 However, it is necessary to check if the products are accepted in your municipality.

Guide to single-use plastic items allowed and prohibited

Federal and Montreal regulations

Montreal and the Government of Canada have adopted regulations prohibiting the sale and offer of some single-use plastic products.

Beside is a summary of the targeted articles, sold at Carrousel.

Effective dates

Montreal: March 28,2023

Ban already in place for plastic bags

Federal: December 20, 2023

The manufacture and import of the banned items will be prohibited as of Decembre 20, 2022.

Federal Regulation

Reusable plastic shopping bags

Bags meeting the following criteria are accepted:

- don't break if they are used to carry 10 kg over a distance of 53 m 100 times;
- don't break if they are washed in accordance with the washing procedures specified for a single domestic wash (standard ISO 6130).

Cutlery and straws

Plastic utensils and straws meeting the following criteria are accepted as they are considered reusable:

- · not made of polystyrene or polyethylene;
- can tolerate 100 wash cycles in a household dishwasher.

Flexible straws

Some exceptions will be in effect for flexible straws. See the federal regulation on this subject.

Foam foodservice ware (expanded or extruded)

They are allowed only if they are trays and are used to package food that is not ready to be eaten (e.g. vegetables, meat, fish)

Black food containers

Only black containers meeting the following criteria are accepted:

- contain foods that need to be prepared (baking in the oven, heating in a microwave or toaster) before they can be eaten or meat and fish that are not ready to eat or vegetables;

Compostable plastic foodservice ware

It is important to differentiate between compostable plastic, such as PLA, and oxo-degradable plastic, which is prohibited. Also note that all black packaging is prohibited, even if it is compostable plastic.

Cups and lids

Foam cups (expanded or extruded) as well as black lids and black cups are prohibited.

Montreal Regulation

Businesses affected and not affected

The regulation concerns establishments located in the boroughs of Montreal that offer food service or that

- package food items for retail sale. Excluded are: establishments that do not receive consumers inhouse and offer only delivery service;
- non-profit organizations whose mission include food distribution.

Cutlery for delivery/takeout

Utensils made of 🚳 plastic are not permitted under any circumstances.

Foam foodservice ware (expanded or extruded)

Seuls les plateaux for emballer de la viande ou du poisson sont permis.

Black foodservice ware

Foodservice ware made of plastic 🐧 (expanded, extruded or not) are prohibited, regardless of their color.

Definitions of materials used for packaging

MATERIALS	DESCRIPTION
Bagasse	Bagasse is the fibrous residue left after the sugarcane has been extracted. This paper-like substance is transformed into a wide variety of products like containers, plates, and bowls.
Cardboard, pulp and paper	Whether it is paper packaging, flat, corrugated or multi-layer cardboard or kraft paper bags, all products made from these materials are fully recyclable. ³
PET (Plastic #1)	Polyethylene terephthalate. The recyclability of this plastic is quite good, as there are some recycling options. RPET is made of recycled PET. ⁴
HDPE (Plastic #2)	High-density polyethylene. HDPE is the most commonly recycled plastic and is considered one of the safest forms of plastic. It is the most coveted plastic resin by recyclers, according to Recyc-Québec. ⁴
PLA	PLA, also known as Polylactic Acid, is a plant-based plastic made from corn starch.2 It is versatile, compostable, and best of all, not petroleum derived.
Aluminium	Foil and aluminum containers can be recycled over and over again. ³
PVC (Plastic #3)	Polyvinyl chloride. Very low recyclability, mainly due to the presence of presence of additives. ⁴
LDPE (Plastic #4)	Low-density polyethylene. Used mainly for plastic bags, low recyclability. It is not normally recycled. ⁴
PP (Plastic #5)	Polypropylene. The recyclability of this plastic is quite good, since it can be recycled several times before reaching the end of its life. ⁴
PS (Plastic #6)	Polystyrene. Very low recyclability. Industrial recycling processes are not very developed and there are only a few recycling options. PS should be avoided where possible. ⁴
Plastic #7	Many plastics are included in this category. Very low recyclability, mainly due to the presence of presence of additives. ⁴

Depending on the product's type, you should consider the following steps before putting it in the trash.




